### **BOOKING**

All race bookings must be made by parents/guardians/teachers/team managers directly with Precise Racing ([emily@preciseracing.co.uk](mailto:emily@preciseracing.co.uk)). Entry forms or Race entry information can be found at [www.preciseracing.co.uk](http://www.preciseracing.co.uk).

### **PAYMENTS**

An entry is only confirmed once Precise Racing have received payment in full. Failure to pay within 28 days of the competition, the entry may be declined, resulting in your child / school losing their place. ### **CANCELLATIONS**

For any cancellations, an email should be sent to [emily@preciseracing.co.uk](mailto:emily@preciseracing.co.uk) to inform Precise Racing as soon as possible so we can issue a full refund, less a 10% administration fee.

If cancellation is within 14 days of the event, unfortunately, we are unable to refund any monies due to illness/injury.

In the event of Precise Racing cancelling the event, a refund of all sums will be paid to Schools/Parents/Guardians, but you will not be entitled to compensation.

In the event of cancellation or curtailment or inability to ski because of inclement weather or lack of snow, no refunds will be made to you unless Precise Racing has obtained a full refund from the relevant service provider(s). In the event of lack of snow, or inclement weather, Precise Racing will endeavour to re-site the event, however this may result in extra costs which will be passed on to you. We strongly recommend you take out cancellation insurance.

## **HEALTH & SAFETY**

There may be occasions where the medical or physical conditions of a child means that it would not be appropriate or safe to include that child in the race event based on the health and safety.

It is the Parents/Guardians/Teachers/Team Managers (the person entering the skier's) responsibility to check their racer's are of a standard to safely compete in the race event.

Appropriate First Aid will be administered to competitors in the event of an accident while involved in our race event by a First Aider. If the accident is more serious, we may need to call the emergency services and will immediately inform parents/guardian/teachers/team managers and work together with the ski resort.

Precise Racing takes no responsibility or liability for any competitors hiring equipment from the ski resort.

## **CHANGES TO SCHEDULE**

Information given on the website and in printed materials are correct at the time of publishing and printing. We may need to change dates, location or activity options due to unforeseen circumstances (or the weather), but we will inform you as soon as possible.
